Bidders are requested to quote their best possible prices with special discount, as the set-up is a non-commercial public service educational initiative supported by University Grants Commission (UGC) and Ministry of Human Resource Development (MHRD), Government of India (GOI). 2. The prices quoted should be inclusive of taxes & F.O.R University campus.
3. The tenders should be accompanied with GST registration certificate.

Tenders from reputable brands of same/similar specifications only, compatible with the tendered items shall only be evaluated. The tenderer must mention Make/Model for the item quoted, supported with original technical literature

4. The tenderer has to produce EMD for an amount mentioned above at the time of submission of the tender document. Tenders not accompanied by EMD shall not be entertained. No interest will be payable on EMD amount.
5. The rates quoted for the item shall remain valid for at least six (6) months from the date of opening of the tender.
